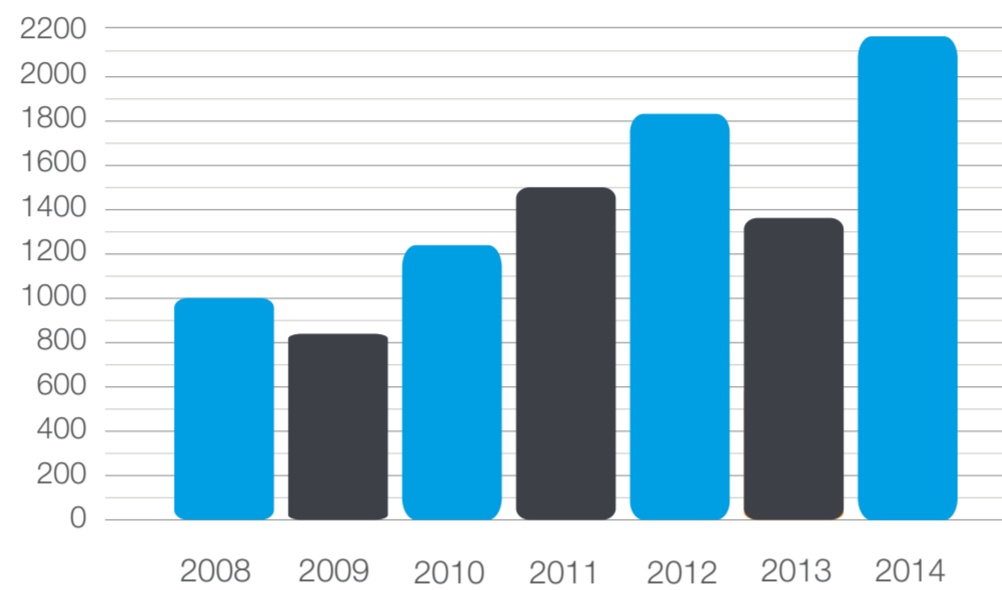

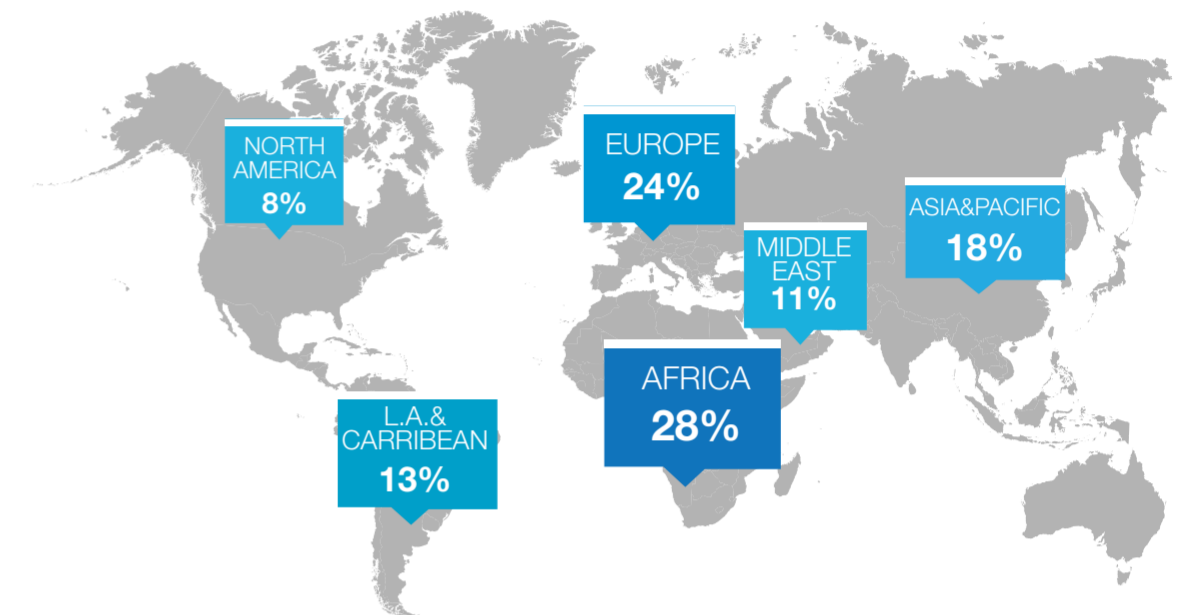

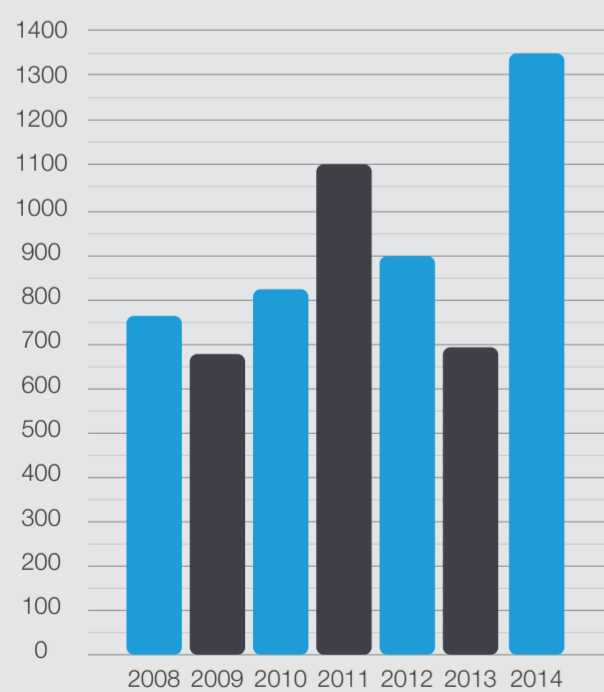
Executive trainings provided to diplomats at major United Nations locations to enhance effective performance in a multilateral context.

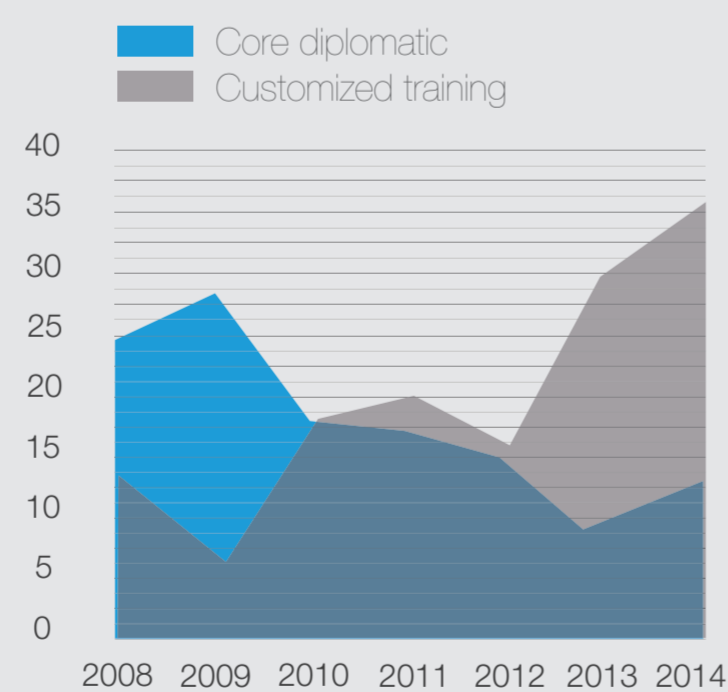
Tailor-made activities on themes related to multilateral diplomacy and international affairs management.

Interactive online courses moderated by senior international experts and professionals building on UNITAR's wealth of experience designing and implementing training workshops on diplomacy and multilateral affairs.

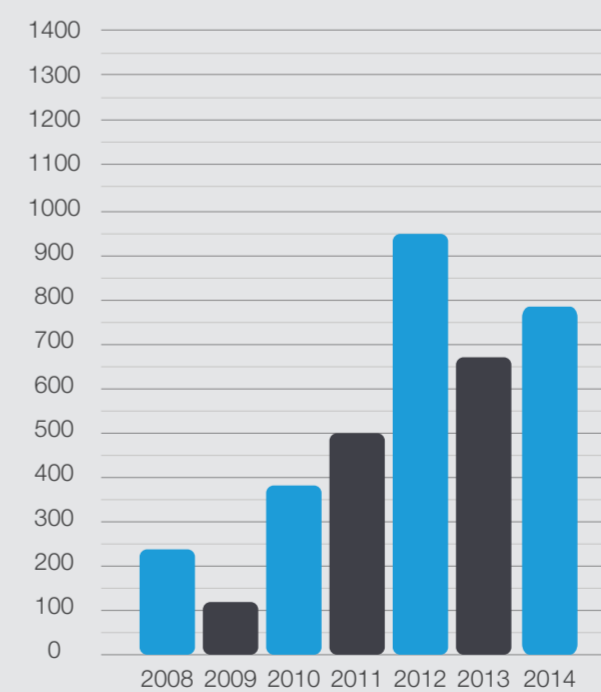
### NUMBER OF FACE-TO-FACE BENEFICIARIES
