
E-Learning Course on Human Rights and Counter-Terrorism in Central Asia

Respect for human rights and the rule of law are behind any successful effort to prevent and counter violent extremism or terrorism in the long-term. This project, designed in collaboration with the United Nations Office of Counter-Terrorism – United Nations Counter-Terrorism Centre (UNOCT-UNCCT), United Nations Regional Centre for Preventive Diplomacy for Central Asia (UNRCCA), United Nations Office for Project Services (UNOPS) and the Office of the United Nations High Commissioner for Human Rights (OHCHR), aims to strengthen the knowledge and increase awareness regarding the protection and promotion of human rights and the rule of law in the context of counter-terrorism in Central Asia. Participants are selected from governments, police and security agencies working in the realm of counter-terrorism in Central Asian countries. The e-learning course builds on the UN Global Counter-Terrorism Strategy and the Joint Plan of Action for Central Asia.

Strengthening Capacity, Collaboration and Innovation of Journalists to Prevent Violent Extremism (PVE)

Journalists can play a significant role in countering violent extremist narratives and challenging conditions conducive to the spread of terrorism. This initiative aims to mobilise journalists by offering a tailor-made framework to address capacity and knowledge gaps and promote innovation and sharing of good practices in and between communities, nations and regions. The framework will include a set of e-learning courses and online training workshops addressing a variety of key topics through an online learning platform. The initiative will be delivered in partnership with the International Federation of Journalists (IFJ).



Conflict Analysis and Early Warning

Strategic, accurate and timely threat analysis is of great importance in order to enable political and military decision makers to successfully respond to threats, enable early intervention and prevent violent conflicts. UNITAR is committed to addressing the existing needs of African Union Member States for stronger early warning and early action mechanisms. For instance, in 2019, UNITAR conducted a training workshop aimed to enhance the data collection (including the use of satellite imagery) and analysis capacities of African Union Member States in cooperation with the African Union Continental Early Warning System (CEWS). The training workshop will be followed by further structural and capacity building activities in collaboration with the African Union.
