STEP 1

Select

Upon request, UNITAR designs and implements courses on multilateral diplomacy and international affairs, including capacity building and skills development on the three UN pillars: Human Rights, Peace and Security, and Development.



STEP 2

Customize

The duration, content and mode of delivery of the courses are defined in close consultation with beneficiaries and partner organizations in order to meet participants' specific needs.



STEP 3

Engage

The training activities can be implemented face-to-face in Geneva, in capital cities and in other locations as well as online via UNITAR's e-Learning platform.

- Delegates, Ministries of Foreign Affairs and Government officials;
- Staff of Diplomatic Academies and Foreign Service training institutions; International Civil Servants;
- Cosmopolitan and Executive Decision-Makers from the private sector.

UNITAR provides a set of training materials, prepared in close cooperation with partners and resource persons, consisting of presentations, selected readings, instructions for interactive exercises and discussion group assignments, relevant publications, etc.


